6. The objects for which the corporation is incorporated are:  
Objets pour lesquels l'association est constituée:

(a) To represent the interests of the students of Trent University to the administration of the University.

(b) To give recognition and financial support to student clubs, organizations and societies within the University.

(c) To study the academic and physical growth or decline of the University and to make suitable recommendations to the appropriate bodies.

(d) To represent the interests of the students of Trent University to other student associations to the municipal, provincial and federal levels of government, and to other organizations outside the University.

(e) To foster in students an awareness of community, provincial, national and international issues and to promote action in relation to these issues.

(f) To administer the affairs of the students of Trent University including, without limiting the generality of the foregoing, the receipt and administration of all funds accruing to the Corporation from the student association fees collected and remitted by the University and such other funds as may become the property of the Trent Central Student Association by any means whatsoever.

(g) To develop and maintain/responsible student association<sup>a</sup> at Trent University.

(h) For the objects aforesaid, to prepare, publish, print, distribute or sell bonds, newspapers, reports, periodicals and printed matter generally to establish and operate athletic and social programs for the students at Trent University.

7. The special provisions are/Dispositions particulières:

For the purpose of the objects of the corporation, to accept gifts, donations and bequests.

The corporation shall be carried on without the purpose of gain for its members, and any profits or other accretions to the corporation shall be used in promoting its objects.

That the Directors shall serve as such without remuneration and no director shall directly or indirectly receive any profit from his or her position as such; provided that a director may be paid reasonable expenses incurred by him or her in the performance of his or her duties.















