

2024-2025 Transit Fees, Terms and Conditions

Every **undergraduate** student, September or January start, at Trent’s Peterborough Campus billed 1.5 or more credits in their starting term (excluding School of Education students) will automatically receive a TCSA Transit Pass, valid from September 1, 2024 to August 31, 2025. The TCSA Transit Pass fee will automatically be included in your student account registration billing. Students not automatically billed who fall under 1.5 credits, or Trent community members who wish to receive a TCSA Transit Pass, are welcome to purchase a 12 month, 8 month or 4 month pass. The **Trent community includes Graduate students, staff or faculty etc..**

Transit pass fees for the 2024-2025 year are:

All TCSA Transit Passes are available for purchase and pick-up in the TrentU Card Office (Blackburn Hall). Please note that city issued 10-ride and 30-day passes may be purchased in the TCSA or Card office. A 10-ride city pass is \$27, and a 30-day city pass is \$72. TCSA and City Transit Passes can be used on all Peterborough bus routes. Your TCSA Transit Pass must be shown to the driver each time you board. If your pass is not shown, you will be required to pay the full adult single ride fare.

Refunds – September start students

Any undergraduate September start student who drops below 1.5 credits, or withdraws from Trent, by the deadline date of September 19, 2024, has until October 4, 2024 to email or visit the TrentU Card Office for a full refund. Failure to do so will result in the transit pass fee of \$324.26 charged to your student account. Students who withdraw from Trent after the deadline date of September 19, 2024 can receive a \$70 refund upon contacting the TrentU Card Office. No refunds will be granted after December 13, 2024. Fall only students who return their transit pass to the TrentU Card Office prior to December 13, 2024 can receive a refund of \$112.00, which will be applied to the student’s account after the Winter 2025 registration deadline of January 20, 2025.

Refunds – January start students

Any undergraduate January start student who drops below 1.5 credits, or withdraws from Trent, by the deadline date of January 20, 2025, has until February 7, 2025 to return the TCSA Transit Pass to the TrentU Card Office for a full refund. Failure to do so will result in the transit pass fee of \$216.17 charged to your student account. Students who withdraw from Trent after the deadline of January 20, 2025 can receive a \$50 refund upon return of their TCSA Transit Pass. No refunds will be granted after April 18, 2025.

Terms & Conditions

Use of this TCSA Transit Pass constitutes acceptance of the terms and conditions outlined herein. This Pass is non-transferable and remains the property of the Trent Central Student Association. Only the student represented on the TCSA Transit Pass is permitted to use the Pass. It is considered fraud to use another person’s Pass or to permit others to use your Pass. If fraudulent TCSA Transit Pass use is suspected, Peterborough Transit has the authority to confiscate the TCSA Transit Pass and report the incident to Trent Security.

Lost or Stolen Passes

A one-time replacement fee of \$55 will be charged for a lost, stolen or damaged plastic TCSA Transit Pass. Students are eligible for one replacement card; additional lost, stolen or damaged cards must be purchased at full cost (please see Fees section). Replacement fees are to be made at the TrentU Card Office (Blackburn Hall).
